### TUITION INFORMATION

Please find the 2026–2027 tuition rates on the reverse side of this letter.

All families are required to utilize FACTS Tuition Management for the 2026–2027 school year. FACTS can be accessed at: **online.factsmgt.com**. Upon registration, a non-refundable deposit of \$200 per child must be paid through FACTS. This deposit will be applied to your 2026–2027 tuition balance.

FACTS will be available for deposit payments beginning February 9, 2026. Tuition billing will take place from July 2026 through April 2027.

Families who anticipate financial difficulty are encouraged to apply for Diocesan financial aid through FACTS. Students must be registered at St. Thomas the Apostle School to apply. Financial aid is available for students in kindergarten through grade eight. Applications will be accepted until April 30, 2026.

### 2026-2027 Tuition Information

A \$200 non-refundable deposit is required at registration. Deposits will be credited to your first tuition payment of the year. FACTS will be ready for 2026-2027 deposit payments starting on February 9, 2026. When making your deposit payment, be sure to choose the 2026-2027 school year. The \$200 deposit per child, paid through FACTS Tuition Management, must be paid upon registering your child.

- The projected cost to educate one child at St. Thomas is \$8,880 for the 2026-2027 school year.

- To be considered a “sponsored family” by St. Thomas Parish for the 2026-2027 school year, parishioners must have contributed at least \$750 to St. Thomas Parish for the calendar year 2025. Parish sponsorship applies to students in kindergarten – grade 8 only.
